## CONDITIONS FOR ENROLLMENT – Please Read

1. All campers, parents, and relatives agree to abide by the rules and regulations set forth by the camp for the health, safety, and welfare of the campers. All camper forms are due immediately upon registration.
2. Due to the fact that all camping programs are planned prior to the opening of camp, including purchasing camper supplies, equipment, and hiring of personnel based on confirmed camper reservations, final payment is due no later than June 10, 2018. No refunds will be issued after June 15, 2018.
3. The camp reserves the right to dismiss any camper whose conduct or influence is unsatisfactory or is, in the opinion of the Camp Director, not in the best interest of the camp. In such event, there shall be no refund in any part of the camp fees.
4. The camp is not responsible for articles of clothing or personal belongings lost or damaged by fire, theft, misplacement, etc.
5. Should both parents not be available by phone for an extended period of time during the camp session, the Camp Director must be notified where they can be contacted in case of an emergency.
6. In case of medical emergency, I hereby give permission to the physician selected by the Camp Director to hospitalize and secure proper treatment for my camper(s). All such expenses will be the sole responsibility of, and shall be paid for by, the parents.
7. The undersigned consents to the use of any photos or videos of their camper(s) to be used for advertising or promotion of Camp.
8. I understand and acknowledge that certain activities as listed in the camp flyers (such as horses, sports, etc.) have an increased risk of injury. I further acknowledge and state that I assume full responsibility for my camper's safety and well-being while he/she is participating in such activities. I hereby agree to release and indemnify Coachella Valley Horse Rescue Horsinalities 101 Camp, and all their officers, employees, agents, and representatives whatsoever from any claims, costs, expenses (including attorney fees), and/or damages which any of them may sustain or incur from my child's participation in such activities.
9. Campers may not place or receive phone calls. Parents are welcome to phone the Camp Moms. Please, do not send cell phones, tablets, or any

electronic devices which are internet enabled. They will be collected and held at the camp office until the end of each day. The camp will not take any responsibility for lost cell phones or electronic devices.

10. We reserve the right to refuse camp attendance.
